1.	I give authority to RSPCA WA to provide a temporary foster home for my pet(s) for one month at a time (for a maximum of three months) or until I request my pet(s) back. I agree to contact RSPCA WA before the end of each one month period to renew this agreement.		
2.	I understand that at no time will I be given access to my pet(s) whilst in foster care and accept that the identity of the foster carer will remain confidential.		
3.	I understand that should my pet(s) show any form of aggression towards people or other animals whilst in foster care, RSPCA WA reserves the right to immediately return the pet(s) to me, or make alternative arrangements.		
4.	I give permission to RSPCA WA to contact my veterinarian for my pet(s) history. I understand and agree that should my pet(s) need to be vaccinated, microchipped or sterilised, such treatment will proceed at my own expense and that payment plans are available for such treatment.		
5.	I authorise RSPCA WA to act on my behalf in seeking and acting on veterinary advice for my pet(s) and understand that should my pet(s) need veterinary treatment, where possible I will be contacted to discuss the same. If I am not contactable and a veterinary surgeon advises that immediate treatment is needed, I agree that such treatment may proceed without my consent, as it will be in the best interest of my pet(s).		
6.	I understand and agree that in the event of serious injury or illness, should a veterinary surgeon advise that the only option is to have my pet(s) humanely euthanased, RSPCA WA will act on this advice, to prevent my pet(s) suffering further.		
7.	I understand and agree that RSPCA WA will not be held responsible in event of injury, illness or death of my pet(s).		
8.	I authorise RSPCA WA to permanently re-home my pet(s) should I leave the women's refuge and fail to make contact with RSPCA WA within 14 days of the expiry of this agreement.
